Email privileges may be revoked for any Member who, in the discretion of the Board, fails to abide by the following reasonable terms of use:

- Copying to multiple email addresses is not necessary. If the party you are intending to reach does not respond within 48 hours, please send an email to <u>Briargrovehomeowners@gmail.com</u> or simply utilize the official Association mailing address.
- For Association correspondence, Members must utilize the email addresses as listed above. Use of individual email addresses for Officers or Board Members without their express permission to do so is not permitted.
- Email addresses are <u>never</u> to be used for libelous, accusatory, harassing or otherwise abusive communications. The Board reserves the right to block any Member who uses any Association electronic communications for this purpose.
- Copying (including screenshots) of the website and disseminating it in any way, in whole or in part, including posting it to ANY Social Media sites or emailing/texting excerpts to others is prohibited.
- Failure to abide by any of the Terms of Use is grounds for a Member being blocked from using electronic means to communicate with the Association. The Board of Directors reserves the right to block any Member, upon a majority vote of the Board, from access to the Association email.

### **Reporting Potential ARC Violations:**

- If you feel that a fellow Member may be in violation of the ARC Guidelines, you may submit a request for it to be reviewed by the ARC by either utilizing the link on the website or by utilizing the official Association mailing address.
- When reporting a potential violation, the following information is required:
  - The address or lot #
  - A short description of the problem (grass needs to be cut, boat on property, etc)
  - A citation of the specific ARC Guideline that you feel is being violated.
  - Do not take pictures of the potential violation without permission from the owner
- Accusatory, harassing or abusive communications will not be responded to.
